In response to the evolution of the Covid-19 outbreak and the latest directives from the Ontario government, we inform you that the suspension of classes (in person) will be extended until March 31st, and then until further notice depending on the evolution of the situation.

Continuity of administrative services

Communication

Given the evolving nature of the situation, we have adapted our communications to ensure regular updates with parents. We are committed to providing regular, transparent information that is as clear as possible.

Continuity of pedagological services

Overview of the first days

All our teams have been mobilized this week so that the adaptation to distance learning can take place as smoothly as possible, but some adaptations or adjustments are to be expected. As such, we invite you to contact the teachers to give them your input.

We stay in close communication with all the pedagogical teams to keep track of requests and are actively working to respond to them as quickly as possible.

Access to documentary and cultural resources

Pronote must be considered as the main reference tool for students, families, and educational staff (most notably for schoolwork planning). All information communicated to students and/or parents, even if it has also been communicated by email, must be accessed via the Pronote application. This way, the information will always be easily accessible.

The ZOOM platform will be used to implement live synchronous timing with classrooms.

In complement to the educational resources offered, the <u>Cultural and Scientific Services of the French Embassy in Canada</u> offers a variety of cultural resources to keep you busy in this period of social distancing.

Orientation

Orientation procedures will continue to take place normally in accordance with the instructions given to us by the Ministry of Education. High school students from Seconde to Terminale can contact Élodie Bouvier, Guidance Counsellor, by email or virtual appointment from Monday to Friday, from 8:30 to 10:00 am and 1:30 to 2:30 pm.
